

PRESIDENCY OF THE COUNCIL OF MINISTERS

Resolution of the Council of Ministers n.º 74/2010

The welcoming and integration of immigrants is one of the political priorities of the XVII Constitutional Government.

With the objective of giving continuity to a new generation of social policies, the Government with the present Resolution approves the Second Plan for Immigrant Integration (2010-2013), which comprises 90 measures across various policy areas. The key objective of the aforementioned Plan continues to be the full integration of immigrants in culture, language, employment, professional training and housing.

The Second Plan also highlights two new areas of intervention: the promotion of diversity and intercultural dialogue, and elderly immigrants. This latter issue is a challenge which has recently emerged with increasing immigration to Portugal and is designed to be a preliminary to the introduction of actions and measures as part the European year for Active Ageing and Intergenerational Solidarity planned for 2012.

All these efforts have met with a very positive reception at international level, as attested by MIPEX (Migrant Integration Policy Index) 2007 and, more recently, the United Nations Human Development Report of 2009, which places Portugal at the top of the ranking in immigrant integration policy. This report acknowledges the initiatives taken by Portugal in this area to be at the cutting edge of immigrant policy, with Portugal given the top ranking in the attribution of rights and services to foreigners residing in the country.

International recognition of this nature represents not only an incentive but also and above all additional responsibility in the implementation and supervision of such policy, in view of the current international economic crisis which on the one hand has led to a stabilization in migrant flows relative to the start of the decade, but on the other has placed immigrants at greater risk of social exclusion, given their greater vulnerability to social problems.

It is precisely because of these economic cycles that the State must act to reinforce and consolidate public policy on integration - policy which is one of the keystones of immigration policy and the social cohesion of the country.

The first Plan for Immigrant Integration, effective from 2007 to 2009, placed Portugal in the restricted group of EU countries which had adopted an instrument for global orientation of public policy on the integration of immigrants. This instrument was cross-ministerial and was implemented with the due supervision. Its implementation rate was extremely high.

Thus, in the wake of this successful experiment and with the objective of ensuring full respect for the rights of migrants and promoting social cohesion, equal opportunities, the integration of immigrants in Portuguese society and intercultural dialogue, new momentum needs to be given to this policy with the adoption of a new Plan for Immigrant Integration. As a government action plan, it naturally acknowledges the fundamental role of all public and private partners, namely the civil society, NGOs and immigrant associations in its implementation.

To ensure the concerted action of all ministries and the supervision and evaluation of the proposed objectives, the Network of Focal Points for Supervision is to be retained, working under the coordination of the High Commission for Immigration and Intercultural Dialogue, I. P. (ACIDI, I. P). This involves the obligatory presentation to the Consultative Committee for Immigration Affairs (COCAI) of an annual report on the implementation of the measures included in the Plan.

Like its predecessor, the Second Plan for Immigrant Integration (2010-2013) was compiled on the basis of joint contributions from all ministries, as well as contributions and proposals from civil society, namely immigrant associations, COCAI members, the Commission for Equality and Against Racial Discrimination (CICDR), and researchers working with the Immigration Observatory.

The government has also decided to submit this Plan to a public consul-



tation procedure, making it available on the websites of the government and of ACIDI. The Plan hereby approved takes into consideration some of the contributions presented as part of this consultation procedure.

The Consultative Committee for Immigration Affairs has been heard. Thus:

According to paragraph g) of article 199 of the Constitution, the Council of Ministers has decided:

To approve the Second Plan for Immigrant Integration (2010-2013), which is annexed to this Resolution and forms an integral part thereof.

To give continuity to the Network of Focal Points for Supervision of the Plan, comprising two representatives from each ministry (one effective and one deputy) acting under the coordination of the High Commission for Immigration and Intercultural Dialogue, and submitting to the Consultative Council for Immigration Affairs an annual report detailing the implementation of the measures outlined in the Plan.


To determine that this Resolution shall be in force on the day following its publication.

PART I

POLITICAL MEASURES

II PLAN FOR IMMIGRANT INTEGRATION. Pii 2010 - 2013 (9)

I. BACKGROUND

The Second Plan for Immigrant Integration is based on an evaluation of the previous plan and on the identification of intervention needs for the period 2010-2013, benefiting from the contributions of all ministries and the participation of civil society, especially immigrant associations or those who work with immigrants, both permanent and essential partners for this national endeavour.

The First Plan for Immigrant Integration had the virtue of identifying a series of needs and the responses to those needs, undertaking to give impetus to the introduction of 122 measures for which 13 ministries were responsible. The evaluation of the implementation of this Plan concluded that its implementation rate was very high and that in many areas the objectives set were even exceeded, although much work remains to be done in all areas.

This Second Plan involves continuity but also innovation. The areas of intervention have been reformulated, with some areas merged and two new areas created. There are now 17 areas of intervention.

Structurally, key features of the new Plan include the diversity and intercultural dialogue areas (which were previously included in a cross-sectorial axis), and the protection and integration of unemployed immigrants and especially elderly immigrants, in an endeavour to respond to the growing challenges posed by immigration to Portugal. This last consideration also takes into account the fact that 2012 is European Year for Active Ageing and Intergenerational Solidarity.

Other changes are in the distribution of the areas, with Media and Religious Freedom now included under a new heading, Promotion of Diversity and Intercultural Dialogue. Family Reunification has been included in Welcoming, while Information Society is now part of the Descendents of Immigrants area. One theme, Sport, has a dual valency which is reflected in its inclusion in not one but two areas: Promotion of Diversity and Intercultural Dialogue, and Racism and Discrimination. Also particularly relevant is the 4th generation of the Choices programme (2010-2012)¹ in the context of the Second Plan for Immigrant Integration. The Choices programme is a fundamental vector in the Descendents of Immigrants area. With the mobilization of substantial investment in human and financial resources and the extensive involvement of local partners, it is hoped that this programme will be a powerful tool for the implementation of social policy designed to promote the integration of immigrants in Portuguese society.

The 90 measures included in the Plan are distributed across the following areas of intervention:

- 1. Welcoming;
- 2. Culture and Language;
- 3. Employment, Professional Training and Business Dynamics;
- 4. Education;
- 5. Solidarity and Social Security;
- 6. Health;
- 7. Housing;
- 8. Justice;
- 9. Racism and Discrimination;
- 10. Access to Citizenship and Civic Participation;
- 11. Immigrant Associations;
- 12. Descendents of Immigrants;
- 13. Elderly Immigrants;
- 14. Relations with the Countries of Origin;
- 15. Promotion of Diversity and Intercultural Dialogue;
- 16. Gender Issues;
- 17. Human Trafficking.

1) WELCOMING

MEASURE 1

Consolidate National Immigrant Support Centres (PCM/ACIDI, I. P.)

Consolidating National Immigrant Support Centres (CNAI) in terms of the response capacity of the offices and departments which they comprise, and the reference structure for the welcoming and integration of immigrants in Portugal.

This consolidation includes increasing the amount of physical areas available in the CNAI of Lisbon, extending opening hours and diversifying the work of the various offices.

The operation of the CNAI centres will be subjected to regular evaluation on the external and internal levels.

MEASURE 2 Consolidate Local Immigrant Support Centres (PCM/ACIDI, I. P.)

Consolidating Local Immigrant Support Centres (CLAII) by extending the services they provide for the welcoming and integration of immigrants, namely conducting diagnostic studies designed to identify migratory dynamics at local level.

To strengthen local networks for the promotion of social conditions favourable to the integration of immigrants.

To evaluate CLAII network operations on a regular basis, using external evaluators.

MEASURE 3

Strengthening the National Immigrant Information Network (PCM/ACIDI, I. P.; MAI/SEF)

Improving the quality of the information provided to immigrants, focussing on the dissemination of available resources and services, and of the rights and duties of immigrants. Improving the standard of information is an objective involving all channels of communication and special efforts will be made to overcome language barriers. The Internet is an important source of information in this respect, and investment will be made in the renovation of the ACIDI website.

MEASURE 4

Improving official data on the integration of immigrants (PCM/ACIDI, I. P./INE, I. P.; ME; MTSS/ISS, I. P./IEFP, I. P; MAI/SEF/DGAI; MCTES/DGES)

To improve the official sources of data on the integration of immigrants, broken down by sex, that exist in the various ministries, with the purpose of calculating indicators, without prejudice of the currently available data on the management of migration and border controls.

Raise awareness among foreign residents in Portugal to participate in the 2011 census.

MEASURE 5

Simplifying the Family Reunification process (MAI/SEF/OLI; MNE; MCTES/DGES)

Simplify the Family Reunification process by extending the range of documents which immigrants can produce as proof of income, via the revision of Ordinance no. 1563/2007 of 11 December, which establishes the proof of means of subsistence required by foreign citizens for their permanent admission to Portugal.

For the descendents (single, aged between 18 and 25 (according to the Income Tax Code dispositions), dependent and residing outside Portugal) of foreign citizens holding a residence permit to be reunited with their parents they must present a document attesting to their enrolment in a Portuguese educational establishment.

MEASURE 6

Improving service to the public at the SEF (MAI/SEF)

Reduce the time it takes to issue the foreign residence permit created to facilitate exchange with public administration departments.

Streamlining interaction between the SEF and the individual concerned via the phased expansion of the workflow system (fully computerized processes) to as many SEF desks as possible.

Enable foreign citizens to schedule appointments with any regional department of the SEF, via the SEF website.

Formalize a closer cooperation between MAI/SEF and local administration - city councils and parish councils - for identifying and reporting situations that require the targeted intervention of the SEF. This measure is designed to ensure that foreign citizens and their families have their documents in order, drawing on the human and material resources assigned to the "SEF in Movement" programme increasing the proximity between the citizens and the SEF services.

Improve, likewise, the assistance given by local authorities to immigrants by allowing the latter to make online appointments for visits to the SEF.

2) CULTURE AND LANGUAGE

MEASURE 7

Consolidate the "Portuguese for All" programme (PCM/ACIDI, I. P.; ME; MTSS/IEFP, I. P.)

Continuing the implementation of the "Portuguese for All" programme, that provides classes in basic Portuguese and technical Portuguese for the immigrant population, potentiating the knowledge of Portuguese as a factor for integration.

This programme is especially important since courses at level A2 (basic Portuguese), involve, for purposes of gaining nationality, authorization for permanent residence and long-term resident status.

Extending the programme to cover levels B1 and B2 (Intermediate Level in the Common European Framework for Languages) to provide immigrants with greater knowledge of the Portuguese language.

Advertise the existence of courses in technical Portuguese via a marketing strategy to be used by the training institutes providing Portuguese for All courses.

MEASURE 8

Consolidate the Portuguese as a Second Language programme (ME/DGIDC/DRE; PCM/ACIDI, I. P.)

Enforce the applicable legislation on Portuguese as a Second Language (PLNM) in articulation with the DRE, with the objective of ensuring the implementation, supervision and evaluation of the activities in this domain.

Increasing awareness of the existence of courses in Portuguese as a second language - targeted essentially to inform the people responsible for children's education.

MEASURE 9

Ensuring that Portuguese Language examinations are taken as a condition for the acquisition of Portuguese nationality (ME/DGIDC; MAI/SEF)

Ensure that Portuguese Language examinations are taken, for purposes of acquisition of Portuguese nationality, in national examination centres and abroad.

MEASURE 10

Strengthening the teaching of Portuguese (ME/DGIDC; MTSS/IEFP, I. P.)

Organizing Portuguese courses for non-native speakers - foreign adults, temporary visa holders and residence permit holders, and immigrants who have recently arrived in Portugal, held in state schools and IEFP, I. P. training centres

Distributing the reference textbook "O Português para Falantes de Outras

Línguas", starting level, in the state schools and IEFP, I. P. training centres where the courses are administered.

MEASURE 11

Basic Literacy Training for Social Insertion Income beneficiaries (ME; MTSS)

Involving immigrants who are entitled to or beneficiaries of Social Insertion Income (RSI) and who have no reading or writing skills in Basic Literacy courses designed to bring them up to obtain a certification of the primary level.

MEASURE 12

Reinforcing the expression of cultural diversity in all domains and activities connected with culture (MC; ME/DRE/DGIDC)

Reinforce the expression of cultural diversity, with special emphasis on the area of culture, by encouraging activities designed to foster intercultural dialogue and exchange, and by supporting initiatives in cultural centres which involve the contribution of immigrants and their cultures of origin.

Encourage reading in various languages via the "Reading + in various accents" initiative to be launched in schools.

MEASURE 13

Raising awareness of cultural producers (MC; PCM/ACIDI, I. P.)

Raise awareness among cultural producers to the importance of the integration of migrants, fighting discrimination and intercultural dialogue.

3) EMPLOYMENT, PROFESSIONAL TRAINING AND BUSINESS DYNAMICS

MEASURE 14

Reinforcing immigrants' entrepreneurship incentives (MTSS; PCM/ACIDI, I. P./FDTI/IPJ, I. P.; MEID/IAPMEI, I. P. /DGAE; MADRP/GPP)

Supporting and giving incentives to the business ideas of immigrants, in a context where entrepreneurship is an increasingly important factor for the integration of immigrants in the employment market.

This support involves the continuation of programmes/projects already being implemented, notwithstanding new forms of intervention which place a premium on the effort and the entrepreneur spirit of immigrants.

Special attention will be given to involving immigrants in the self-employment creation incentive programme known as the Immigrant Entrepreneur Programme (PEI), an immigrant assistance programme which includes a Mentor Programme (mentors are trained volunteers who offer immigrants assistance in the business creation process).

MEASURE 15

Reinforcing inspection of employers using illegal immigrant labour (MTSS/ACT; MAI/SEF)

Intensify action against the use of illegal labour via reinforcement of the inspections of employers.

MEASURE 16

Reinforce the rendering of information/training for immigrant workers on their rights and duties regarding employment issues (MTSS/ACT/CITE; PCM/ACIDI, I. P.)

Produce information on the rights and duties of immigrants in matters of

employment, in foreign languages and on various supports, in such a way as to reach more people.

Establishing a partnership between ACIDI, I. P., ACT, IEFP, I. P., SEF and bodies Network representing employees and employers, with the aim of equipping Rede CLAII employees on a national and decentralized basis with the skills they need to provide more and better information to immigrants on employment issues.

Informing on the rights and duties of employers with regard to the recruitment of foreign labour - this information will be disseminated on various supports, while a conference will be held with the participation of SEF, employers' associations, unions and immigrant associations, in order to reach as many people as possible and achieve the desired convergence of action from all relevant parties.

MEASURE 17

Simplifying the qualifications recognition process (MCTES/DGES; PCM/ACIDI, I. P.; MADRP/GPP)

Reinforce the articulation between the DGES and the CNAI and CLAII, with a view to simplify the procedures for the recognition of qualifications and guaranteeing the correct handling of these processes in articulation with the professional bodies.

Produce an e-flyer on good practices in the recognition of higher educational qualifications issued by foreign institutions.

Create a database containing all equivalences of higher education diplomas recognized by the Portuguese universities. This database will be continuously updated with information on course, country, first and final years of course, and partial or total equivalence.

MEASURE 18

Incentives for the social responsibility of organizations, based on ethical principles and the promotion of diversity (PCM/ACIDI, I. P.; MTSS/CITE; MEID/IAPMEI, I. P./DGAE)

Giving continuity to the Workgroup on Social Responsibility created as part

of the original Plan for Immigrant Integration, with a view to promoting the social responsibility of organizations, on behalf of cultural diversity and the respect for the rights of immigrants, with the creation of an ethics benchmark.

MEASURE 19

Creating an information system on highly-qualified immigrants (PCM/ACIDI, I. P./FDTI; MCTES/DGES; MAI/SEF; MTSS/IEFP, I. P.)

Creating, in close articulation with Network CLAII and Occupational Insertion Offices (GIP), a comprehensive database of information on immigrants with higher-level qualifications (Information Systems areas) in view of the areas in which training is available or which are underused by the employment market.

MEASURE 20

Consolidation of the Intervention Programme for Unemployed Immigrant Workers (MTSS/IEFP, I. P.; PCM/FDTI)(MTSS/IEFP, I. P.; PCM/FDTI)

Continue the Intervention Programme for Unemployed Immigrant Workers, which is designed to facilitate the social and professional integration of immigrants via the development of basic skills in the Portuguese language and citizenship, professional training and support to job creation. Support for the professional integration of immigrants includes building individual solutions geared towards integration trajectories which leverage programmes and measures for employment and vocational training, depending on existing resources, namely training in Communication and Information Technology (TIC) for the acquisition of crucial skills to employment prospects.

MEASURE 21

Facilitation and promotion of access to professional training and employment (MTSS/IEFP, I. P.; PCM/ACIDI, I. P./FDTI)

Leveraging the GIP network, in partnership with community bodies such as

immigrant associations, to provide more and better professional training, vocational guidance and training / employment advice, including training in the CIT area.

MEASURE 22

Guaranteeing the renewal of immigrant residence permits in the event of employers' non-compliance with Social Security obligations (MTSS; MAI/SEF)

Ensuring that non-compliance with point 2 of article 63 of Decree no. 84/2007 of 5 November on the presentation of tax and social security papers for the renewal of residence permits, as attested by the competent offices, does not constitute an obstacle to the renewal of permits.

The aim of this measure is to prevent that the failure of certain employers to comply with their obligations, namely their failure to pay social security contributions, is detrimental to the renewal of permits by those entitled to them.

4) EDUCATION

MEASURE 23

Reinforcing Training in Intercultural Dialogue as part of Continuous Teacher Training (ME/DRE/DGIDC; PCM/ACIDI, I. P.; MCTES/DGES)

Extend the skills of teachers working in increasingly multicultural contexts by strengthening continuous training in the form of short-term vocational training and training workshops organized by teacher training centres.

MEASURE 24

Defining and implementing recommendations for the constitution of balanced school classes and bringing school strategies into line for the welcoming of foreign students and descendents of immigrants (ME/DGIDC/DRE)

Guaranteeing and monitoring the constitution of balanced class compositions, based on the recommendations of the Ministry of Education, ensuring a balanced "ethnic mix".

Reinforcing diverse strategies for supporting the integration of school students whose parents are immigrants, taking into account characteristics such as age, language ability and time spent in Portugal, namely through compliance with deadlines stipulated for conditional enrolments.

Providing foreign minors with no residence papers access to professional training as a special schooling option, clarifying the restrictive interpretation given to the wording of article 2 of Decree-Law no. 67/2004 of 25 March and, consequently, implementing Order no. 995/2004 of 9 August.

Clarify the conditions for the award of equivalences to foreign students, by subject.

MEASURE 25

Improve the collection of statistical data on cultural diversity in schools (ME; PCM/ACIDI, I. P.)

Create a workgroup whose job is to efficiently oversee the systematization of statistical data on foreign students and students whose parents are immigrants, by building a statistical monitoring tool to be implemented by schools, ensuring the anonymity of the students concerned.

MEASURE 26 Diversification of offerings in education and training (ME; MTSS; MCTES/DGES; PCM/FDTI)

Promoting access to school-business partnership projects to increase the diversity of educational options in a manner that responds to the needs of students.

MEASURE 27

Integration of intercultural mediators in the school context as part of the "Educational Territories for Priority Intervention" programme (ME)

Reinforce, as part of the "Educational Territories for Priority Intervention" (TEIP) programme, the presence of intercultural mediators in schools, guaranteeing their recognition as members of the educational community and key partners in the integration and learning process.

MEASURE 28

Access by foreign students to social action support in school, at all levels of education (ME; MCTES)

Promote access to social action support in school by immigrant children attending pre-school and immigrant children in primary and secondary education by extending proof of income requirements.

Ensure that foreign students, and the descendents of immigrants, have access to study scholarships, on condition that they have been legally resident in Portugal for at least 5 years.

MEASURE 29

Informing schools of intercultural teaching resources (PCM/ACIDI, I. P.; ME/DGIDC/DRE)

Inform schools and school groupings of the existence of intercultural teaching resources for intercultural and anti-racist education. Consolidate the training and information resources offered under the Trainers Team on Immigrantion and Integration of ACIDI, I. P.

MEASURE 30

Dissemination of best practices in the welcoming, aid and integration of students who are descendents of immigrants (ME/DGIDC/DRE)

Disseminate best practices on the level of education and the level of partnerships with other organizations, such as city councils and immigrant associations, with regard to the welcoming, aid and integration of students who are descendents of immigrants.

MEASURE 31

Support for the welcoming and integration of foreign students and students who are descendents of immigrants in Portugal (ME; MCTES/DGES)

Reinforcing cooperation between MCTES/DGES and higher education institutions with regard to information for foreign and immigrant-descendents students, via information actions directed at the principal actors and with the objective of overcoming the obstacles posed by the deficient training of the information providers, i.e. university secretariats and administrations.

MEASURE 32

The "SEF goes to school" initiative (MAI/SEF; ME)

Streamlining document regularization processes for immigrant minors attending state schools.

5) SOLIDARITY AND SOCIAL SECURITY

MEASURE 33

Humanitarian aid for immigrants living in extreme poverty (MTSS)

Ensuring social assistance and respect for the rights of immigrants living in situations of extreme poverty, regardless of their residence status, on the basis of the definition of humanitarian emergency as applied to Portuguese citizens.

MEASURE 34

Creation of social security conventions with the countries of origin of immigrants' communities represented in Portugal (MNE; MTSS)

Work to secure social security conventions with Guiné-Bissau, India and Russia, like those already in place with Ukraine, Moldova, Brazil and Cape Verde.

6) HEALTH

MEASURE 35

Promoting access by immigrants to the National Health Service (MS/ARS)

Implementing strategies which reduce inequalities in the health system by providing the resources and introducing the measures which permit or help the health service to cater to the needs of immigrants in accordance with the strategies to be established in the National Health Plan 2011-2016.

Informing immigrants of their rights and duties with regard to the National Health Service (SNS), including Law no. 33/2009 of 14 July which establishes the right to receive emergency treatment from the SNS, and the information circular issued by the Directorate General for Health (12/DQS/DMD, of 7 May) on the access of immigrants to the SNS.

MEASURE 36 Training plan for intercultural skills of SNS employees (MS; PCM/ACIDI, I. P.)

Extend to all regional health authorities the Training Plan for Intercultural Skills previously implemented by the regional health authority of Lisboa e Vale do Tejo, I. P. in conjunction with ACIDI, I. P., directed at the healthcare professionals working in the SNS and with particular emphasis on the administrative area.

MEASURE 37

Implementation of a migrant-friendly healthcare services programme (MS/DGS/ARS)

Disseminate the international "Migrant-Friendly Hospital" benchmark in the National Health Service, as well as the recommendations of the Amsterdam Declaration deriving from this project, with the objective of improving services and organizational culture vis-à-vis the immigrant population.

This benchmark involves prior diagnosis of needs, performed via a broadbased consultation of services, experts and organizations / associations in the area of healthcare, with the objective of improving clinical performance, producing migrant-friendly information and providing training on maternal and infant care, as well as vocational training for healthcare professional to improve their cultural skills.

MEASURE 38

Developing partnerships for the promotion of immigrants' access to healthcare in Portugal (MS/DGS/ARS; PCM/IPJ, I. P.)

Empower communities for the creation of environments conducive to good health, taken in its broadest acceptation as a state of physical, psychological, social and spiritual well-being, via the activation of a network of local partnerships and the establishment of new ones, involving different social actors ranging from public and private organizations to NGOs, civil, religious and social action associations and other sectors of society, bearing in mind that the most important factor for success is the citizens' involvement in the whole process.

Encourage young immigrants to adopt a healthy lifestyle in an environment which integrates them in the healthcare system. The establishment of strategic partnerships for the promotion of health is based on the conviction that this type of associative work increases the capacity of the healthcare system as well as the partners involved to accomplish shared objectives.

MEASURE 39

Institutionalization of procedures designed to improve the management of Health Agreements and facilitating access by immigrants and their companions to health services (MS; MTSS/ISS, I. P.; PCM/ACIDI, I. P.)

Institutionalizing procedures for global management of the medical assistance process for patients evacuated from African Countries with Portuguese as an Official Language (PALOP), under the cooperation agreements in healthcare signed by Portugal and the PALOP countries.

The Foreign Patient Assistance Programme (PADE) promoted by ACIDI, I. P. in conjunction with the ISS, I. P., provided a response to some of the problems faced in this area, and served as a resource for the welcoming and supervision of patients and the people accompanying them.

MEASURE 40

Investing in the promotion of mental health among immigrants (MS)

Promoting, via the National Mental Health Coordinating Office and in articulation with the National Council for Mental Health, a special programme involving various institutions and designed to provide a forum for the exchange of information and experiences, within a training context or open to the public, for efficient action in an extremely complex area. The articulation with non-government bodies, some of which have vast experience in this area, is particularly important.

7) HOUSING

MEASURE 41

Expanding the social housing market in articulation with local authorities (MAOT/IHRU, I. P.)

Promoting via the Programme for Funding for Access to Housing (PROHABITA/ PER) and other suitable mechanisms, in articulation with local authorities new responses to housing problems, namely through providing immigrants with housing in shared, unsegregated conditions.

MEASURE 42

Creating new social housing solutions in partnership with Immigrant Associations, IPSS, NGOs and Cooperatives (MAOT/IHRU, I. P.)

Creating and developing new solutions for social housing – working in partnership with immigrant associations, private institutions of social solidarity (IPSS), NGOs and cooperatives – accessible to all immigrants legally present in Portugal, via the mechanisms operated by IHRU, I. P.

MEASURE 43

Improve access of immigrants to rent assistance mechanisms (MAOT/IHRU, I. P.)

Consolidate access by immigrants to rent relief schemes, on an equal footing with Portuguese citizens, via approval of the New Social Housing Rent Regulations (NRAU Social), Porta 65-Jovem and the Public Rental Housing Stock (PHAP).

MEASURE 44 Raising awareness of the need for effective compliance with the contractual obligations undertaken with tenants of IHRU, I. P. (MAOT/IHRU, I. P.)

Alerting and informing beneficiary immigrants of the existence of rehousing programmes for compliance with contractual obligations, i.e. payment of rent and upkeep of dwellings, respect for and preservation of public areas with effective punishment in the case of non-compliance.

MEASURE 45

Reinforcing integrated social intervention projects (MAOT/IHRU, I. P.)

Implementing urban rehabilitation partnerships committed to a new territorial approach with the residents, including immigrant communities.

8) JUSTICE

MEASURE 46

Consolidating cooperation between MAI/SEF and the MJ (MAI/SEF; MJ/DGSP/DGRS)

Create a focal points partnership between MAI/SEF and the DGRS, with the objective of examining situations requiring intervention, namely young foreigners at risk and situations of recognition of legal liability by officially-recognized bodies, with the objective of regularizing residence status and protecting the wider interests of the young people.

Promoting articulation between SEF and the DGRS to make it easier for adults to regularize their residence status with supervision by social rehabilitation teams, in compliance with community implementation measures, wherever no supplementary expulsion penalty exists.

Promote the "SEF in Movement" project as part of the formal articulation

of the activities of the MAI/SEF with the MJ in general and the public prosecutor's office in particular. The objective is to streamline administrative procedures for regularization of minors who are obligatorily subject to guardianship, as stipulated in paragraph e) no. 1 of article 122 of Law no. 23/2007 of 4 July. Promote articulation between the SEF and DGSP with the objective of making it easier for illegal immigrants serving sentences in Portuguese prisons to regularize their status, on condition that they are not subject to any expulsion order.

MEASURE 47

Access to foreign prisoners and information on the implementation of penalties and custodial measures (MJ/DGSP)

Produce information in several languages for foreign prisoners on the implementation of penalties and custodial measures, as per no. 2 of article 117 of the Code of Implementation of Penalties, for distribution in prison establishments (EP).

MEASURE 48

Incentives for consular representatives of the countries of origin of immigrants to play an active role in assistance for foreign prisoners (MJ/DGSP; MNE/DGACCP)

Promote cooperation with diplomatic and consular representatives of the states of origin of foreign prisoners, working in close cooperation with the competent national bodies to supervise the social integration of these prisoners during and after completion of their sentence.

MEASURE 49

Improving efficiency of nationality application processing (MJ/CRC; MAI/SEF)

Reduce administrative times for processing applications for nationality and providing information not only on the conditions for obtaining nationality but also on the pending procedures.

MEASURE 50

Legal aid for immigrants who are victims of crime (MJ; MTSS)

Adopting regulatory, organizational and practical measures designed to ensure access to legal aid by immigrants who are victims of human trafficking, domestic violence, serious crime and abetting illegal immigration.

MEASURE 51

Reviewing conviction requirements for cases of domestic violence (MAI/SEF; MJ; PCM/CIG)

Review conviction requirements in cases of domestic violence for the award of autonomous residence permits, for rehoused family members who are victims of domestic violence.

MEASURE 52

Improving the immigrants' access to translation and interpretation services in interaction with the legal system (MJ; PCM/ACIDI, I. P.)

Improve the access of immigrants to translation and interpretation services in situations of interaction with the legal system, including alternative means of settling disputes, either via the presence of interpreters or via the telephone translation service (STT) of ACIDI, I. P.

MEASURE 53

Promoting foreign prisoners access to the National Health Service (MJ/DGSP; MS)

Promote greater articulation between the MJ and the MS to make it easier for foreign prisoners to gain access to the National Health Service by issuing more SNS user cards.

9) RACISM AND DISCRIMINATION

MEASURE 54

Legislative changes to reinforce the intervention capacity of the Commission for Equality and Against Racial Discrimination (PCM/ACIDI, I. P.)

Approve a proposal for alteration to the current legal framework on regulatory offences for the practice of discrimination according to nationality or ethnic origin, to make processes more efficient by making mediation part of the legal process, establishing deadlines for examination phases, and simplifying procedures.

MEASURE 55

Awareness and training for combating racial discrimination (PCM/ACIDI, I. P.; MTSS/ACT)

Renovating the CICDR website to give it more functionality and bring it closer to visitors, making it both an information resource and a platform for filing complaints about racial discrimination.

Reinforce training of NGOs and immigrant associations in combating racism and discrimination.

Promoting an event centred on effective equality of opportunity in employment, combating all forms of racial discrimination.

MEASURE 56

Combating racial discrimination in sport (PCM/IDP, I. P./ACIDI, I. P.)

Disseminate messages on combating racism and promoting intercultural diversity in relevant sporting events, i.e. championship ties in the principal sports, in articulation with the respective sporting federations.

MEASURE 57 Breakdown of statistical data (MTSS/ACT)

Collecting and processing statistical data on racial discrimination, differentiated by gender, on the basis of regulatory offences for general discrimination in employment.

10) ACCESS TO CITIZENSHIP AND CIVIC PARTICIPATION

MEASURE 58

Promoting the registration of the immigrant population eligible for voting in elections (PCM/ACIDI, I. P.; MAI/DGAI)

Reinforce services to immigrant citizens via the creation of a Voter Registration Office within the CNAI, with the mission of providing support for the registration of immigrants in articulation with the DGAI and parish councils.

MEASURE 59

Consolidate information/training for immigrants on their rights as consumers (PCM/ACIDI, I. P.)

Reinforcing information and training from/by the Immigrant Advice Office on Consumer Affairs of the CNAI, directed at immigrants.

11) IMMIGRANT ASSOCIATIONS

MEASURE 60

Promoting associative action among immigrant communities (PCM/ACIDI, I. P./IPJ, I. P.)

Promote the formation of associations in immigrant communities by providing information and training, with the organization of information/awareness actions. Special emphasis goes to youth involvement in associations.

Leveraging the use of the different media in which ACIDI, I. P. is present, i.e. the "Nós" and "Gente Como Nós" programmes, with publication of a newsletter promoting the formation of associations among immigrant communities.

MEASURE 61

Supporting recognition of representativeness of immigrant associations (PCM/ACIDI, I. P./IPJ, I. P.)

Support immigrant associations in the representativeness recognition process - diagnosing needs, designing and programming activities, creating supervision and evaluation mechanisms, and facilitating contacts and partnerships for sources of financial sustainability.

This assistance also involves visits to associations whose recognition is pending.

MEASURE 62

Supporting the management of association-based projects for the integration of immigrants (PCM/ACIDI, I. P./FDTI/IPJ, I. P.)

Supporting the technical and financial management of immigrant association projects designed to promote the full integration and equal opportunities of immigrants and their descendants, positively projecting diversity and intercultural exchange, gender equality and the political participation of immigrants and their descendents. On the training / information level, network-based mini-actions and training sessions will be held for the leaders and staff of immigrant associations, namely in IT.

MEASURE 63

Revision of law on immigrant associations (PCM)

Alter the legislation to promote greater consolidation in the immigrant association movement, supporting the credibilization of their structures, stimulating the representativeness of immigrant communities and effective operations by associations.

12) DESCENDENTS OF IMMIGRANTS

MEASURE 64

Combating social, educational and occupational exclusion of the descendents of immigrants (PCM/ACIDI, I. P./IPJ, I. P; ME; MTSS/IEFP, I. P.)

Consolidating local projects implemented as part of the Choices programme by groupings of local, regional and central bodies looking to secure an integrated response to the social, educational and occupational exclusion of vulnerable children and youths, promoting a more effective integration.

Defend the equality of opportunity for the descendents of immigrants in access to professional training and employment, combating all forms of racial discrimination.

Developing intervention strategies aimed at combating school failure of the children of immigrants, projecting a positive image of schools, including higher education colleges, as agents of socialization and promotion of vertical social mobility, in a perspective of greater proximity to the community.

MEASURE 65 Combat the territorial segregation (PCM/ACIDI, I.P.)

Reinforce the presence of the Choices programme in the most vulnerable areas, cultivating proximity with the local population and seeking to deconstruct the negative image generally associated with these areas, establishing more direct contact with the local population.

Facilitate exchanges between children and youths who are the descendents of immigrants all over the country, by organizing an annual exchange meeting.

Appointing, as part of the Choices programme, a community animator belonging to the community and acting as a member of the teams assigned to the Choices programme, whose positive leadership profile allows him/her to serve as a role model, and who contributes, through his/her strong ties with the area, to the mobilization of children, youths and the community in general.

Bring ACIDI, I. P. closer to the immigrant communities present across Portugal, to gain better insight into migratory dynamics at local level and those active in the welcoming and integration process.

MEASURE 66

Combating info-exclusion (PCM/ACIDI, I. P./FDTI)

Leverage CIT as a vector for social integration, ensuring the digital inclusion of the descendents of immigrants, their families and the surrounding communities via the Choices programme. Particularly relevant in the struggle against info-exclusion are the Digital Inclusion Centres (CID@net).

MEASURE 67

Raise the media awareness on immigration issues (PCM/ACIDI, I. P.)

Reinforcing media awareness of the need to examine immigration issues in a rigorous fashion, with awareness of the value of intercultural diversity and of the efforts towards integration made by immigrant communities, including residents of the most vulnerable neighbourhoods. Disseminate positive practices among residents of the most vulnerable neighbourhoods, which are often the focus of intense media attention due to sporadic outbreaks of violence - attention which generates a negative public image of these neighbourhoods and their residents, who thereby become victims of another kind of violence.

Disseminating the work accomplished in the projects supported by the Choices programme, as the reflection of a more positive side of the socio-economic context in which immigrants live, and mobilizing information resources - the Choices newsletter - behind these efforts.

MEASURE 68

Support for reconciling the private, family and working lives of immigrant families (PCM/CIG; MTSS; ME)

Helping immigrants reconcile their private, family and working lives, stressing the importance of the participation of both parents in this process, via access to infrastructures such as kindergartens and pre-schools operating in areas of high immigrant density.

13) ELDERLY IMMIGRANTS

MEASURE 69

Counting the socio-economic vulnerability of elderly migrants by the dissemination of available solutions (MTSS/ISS, I. P.)

Informing elderly immigrants and their families of the social assistance available to them, and facilitating their access to such assistance with the objective of combating their socio-economic vulnerability and social segregation.

MEASURE 70

Informing immigrants on forms of access to rights deriving from the payment of social security contributions, not only in Portugal but also in the European Union and in the immigrants' countries of origin (MTSS/ISS, I. P.; PCM/ACIDI, I. P.)

Informing immigrants of the rights deriving from their social security contributions, not only in Portugal but also in the EU, access to which rights is often difficult or even impossible. To combat this problem, special information materials will be created.

14) RELATIONS WITH THE COUNTRIES OF ORIGIN

MEASURE 71

Support the creation of workgroups on the integration of immigrants between countries of origin and Portugal (MNE/IPAD, I. P.; PCM/ACIDI, I. P.)

Reinforce international and interministerial articulation, with the necessary involvement of the general public, between countries of origin and destination, which has been shown to be an effective tool for the integration of immigrants. The Joint Portugal-Cape Verde Consultative Commission (CCC) is an example of this, with the objective being to strengthen the mechanisms by which it works via the organization of an annual meeting and a conference held during the effective period of the Plan.

MEASURE 72

Coordinating the award of scholarships with the needs of countries of origin to counteract brain drain (MAI/SEF; MCTES/FCT/DGES)

Identify areas in countries of origin with the greatest shortage of qualified

professionals, with selective award of scholarships to overcome these shortages. These measures will also help reverse the brain drain often cited as an obstacle to the development of the countries of origin of many immigrants.

MEASURE 73 Reinforcing support for circular migration (MNE/IPAD, I. P.; MAI/SEF; PCM/ACIDI, I. P.)

Promoting circular migration in articulation with the respective countries of origin; protecting acquired rights via bilateral agreements.

MEASURE 74

Promoting the involvement of immigrant associations in the development of their countries of origin (MNE/IPAD, I. P.; PCM/ACIDI, I. P.)

Promote the involvement of Portugal-based immigrant associations in the development of their countries of origin, within the framework of Portuguese government policy on development support.

15) PROMOTION OF DIVERSITY AND INTERCULTURAL DIALOGUE

MEASURE 75

Incentives for the development of self-regulation mechanisms in the media, structured around codes of professional ethics (PCM/ACIDI, I. P.; MAP/GMCS)

Providing incentives for the development of self-regulation mechanisms for media coverage of immigration issues, respecting the autonomy of the media and the professional ethics of journalists with regard to the accuracy of facts and presentation, with the objective of countering the perverse effects which the xenophobia induced by certain manners of presenting news can generate in public opinion. Distributing relevant documentation produced by international organizations - the European Union, Council of Europe and UNESCO - among the principal representatives of the media sector.

MEASURE 76

Promoting cultural and religious diversity in the media (PCM/ACIDI, I. P.; MAP/GMCS)

Urge the media to dedicate air time to programmes and information which examine the cultural and religious diversity of Portuguese society, projecting a positive image of the cultural and linguistic expression of immigrant cultures with communities in Portugal.

Develop information and training initiatives on intercultural dialogue, immigration and diversity with media professionals.

MEASURE 77

Raise public awareness of the need to promote and celebrate diversity (PCM/ACIDI, I. P.)

Promote initiatives to mark commemorative days and other important dates with the objective of raising public awareness of the need to promote diversity, celebrating it and promoting intercultural and interdenominational dialogue.

MEASURE 78

Strengthening the local dimension of intercultural dialogue and integration of immigrants (PCM/ACIDI, I. P.)

Promoting, via Network CLAII, intercultural dialogue as a support strategy for the multivectorial process of welcoming and integration of immigrants at local level, via the implementation of projects designed to improve integration processes and promote positive interaction with the host society.

Encouraging the promotion of local projects for the integration of immigrants, with the production of two manuals on good practices, one directed at administrative personnel and the other at political decision-makers.

MEASURE 79

Raising awareness and capacitation for intercultural and interdenominational dialogue in the welcoming and integration of immigrants in public services (PCM/ACIDI, I. P.)

Raise awareness among, and capacitating, central and local public administration employees for the intercultural dimension in the welcoming and integration of immigrants, via reinforced information and awareness initiatives.

Raising awareness among employees directly dealing with the public in public service offices and equipping them with the interdenominational dialogue skills they need, via information and training.

MEASURE 80

Creating of proposals for training and a benchmark in intercultural skills (PCM/ACIDI, I. P.; MTSS; ME/ANQ)

Creating proposals for training and a benchmark for training in intercultural skills, based on the recognition of the importance of the presence of interculturallyenabled agents in the CNAI of ACIDI, I. P., in the Contact Centre of SEF, in specific contexts such as public services and in local authorities in general, as mediators between immigrants and State.

MEASURE 81

Diagnosting the insertion of intercultural mediators in the different sectors of public services (PCM/ACIDI, I. P.)

Evaluating the impact of the presence of intercultural mediators in public services which are the object of specific projects, namely the action plans of the services to which they are detailed and gathering information on the improvements perceived in the welcoming of immigrants in these services, by both parties - immigrants and public service employees.

16) GENDER ISSUES

MEASURE 82

Reinforcing gender mainstreaming in the welcoming and integration of immigrants (PCM/ACIDI, I. P./CIG)

Reinforced focus on the gender dimension in the welcoming and integration of immigrants, with gender mainstreaming and a focus on the relationships between men and women, in all spheres of society and for the benefit of both genders, taking into account the needs, interests, skills and talents of women and men immigrants. The aim is to bring together the conditions necessary for responding to international recommendations - those of the Convention for the Elimination of all forms of Discrimination Against Women (CEDAW) - relative to immigrant women specifically, and in a more general sense to the gender issues involved in immigration.

MEASURE 83

Providing immigrant women with information on their specific rights and duties as women (PCM/CIG/ACIDI, I. P.; MTSS/CITE; ME/DGIDC)

Promote information and awareness campaigns on the rights and duties of immigrant women, as a complement to and in articulation with the National Plan for Equality, via the compilation of information in various languages.

MEASURE 84

Equipping intercultural mediators with the skills they need to deal with the public in public services and the personnel of Network CLAII in gender issues and domestic violence (PCM/CIG/ACIDI, I. P.)

Equipping intercultural mediators with the skills they need to deal with gender issues and domestic violence (this latter typically a manifestation of gender

violence). These mediators are ideally positioned to deal with such issues given their role as a link between immigrants and public services, with the objective of improving services and/or putting issues through the correct channel, both institutionally and emotionally.

MEASURE 85

Promoting the participation of women in associations and entrepreneurship (PCM/CIG/ACIDI, I. P./FDTI)

Contribute to the empowerment of immigrant women in associations and entrepreneurialism, with the objective of better defending their rights and improving their socio-economic condition by giving them the independence they need to achieve these goals.

MEASURE 86

Preventing domestic violence and gender violence among immigrant men and women (PCM/CIG/ACIDI, I. P.; MAI/SEF)

Contributing to the prevention of all forms of gender violence, including domestic violence and female genital mutilation, among immigrant men and women by providing them with access to information, producing information materials translated into several languages, creating forums where these issues can be discussed, and via the media.

17) HUMAN TRAFFICKING

MEASURE 87

Developing actions for combating human trafficking (PCM/CIG; MAI/SEF; MDN/Marinha/AMN)

Reinforce awareness campaigns on human trafficking in an attempt to counter this phenomenon.

Raise awareness and inform immigrant associations and professionals working with immigrants of how to prevent human trafficking, namely for purposes of labour exploitation.

MEASURE 88

Create a support and protection programme for victims of human trafficking (PCM/CIG; MAI/SEF; MTSS/ISS, I. P.)

Create the Association for Support and Protection of Victims of Human Trafficking, bringing together government and NGOs working directly or indirectly on issues concerning human trafficking, as a means of securing improved intervention and more coherent intelligence, improving sources of information for the criminal investigation and elimination of the problem.

MEASURE 89

Referral to and welcoming at the Refuge Centre for victims of human trafficking (PCM/CIG; MAI/SEF; MJ; MTSS/ISS, I. P.)

Disseminating on national level the contact details of the multidisciplinary team for victims of human trafficking and ways of referring victims to the Refuge Centre, and providing victims of human trafficking and their children with full support thanks to the combined efforts of State and society.

MEASURE 90

Consolidation of the Observatory of Human Trafficking (MAI; PCM/CIG; MTSS/ISS, I. P.)

Consolidating the mission of the Observatory of Human Trafficking with the production, collation, processing and distribution of information and intelligence on human trafficking and other forms of gender violence, in articulation with the National Plan Against Human Trafficking.
